6. Pre-bid meeting shall be held at **Rawabeshi Rural Municipality, Office of Rural Municipal Executive, Haramtar, Khotang, Nepal** at **17:00 hrs on 12 Baishakh, 2078 (25 April, 2021)**.
 7. Electronic bids (one Technical Bid and other Price Bid) must be submitted through PPMO's eGP system www.bolpatra.gov.np/egp on or before **12:00 Hrs. on 22 Baishakh, 2078 (05 May, 2021)**. Bids received after this deadline will be rejected.
 8. The Technical bids will be opened electronically in the presence of Bidders' representatives who choose to attend at **17:00 Hrs. on 22 Baishakh, 2078 (05 May, 2021)** at **Rawabeshi Rural Municipality, Office of Rural Municipal Executive, Haramtar, Khotang, Nepal**. Bids must be valid for a period of 120 days after bid opening and must be accompanied by a bid security or scanned copy of the bid security in pdf format in case of e-bid, amounting to a minimum of as mentioned in the table in clause 2 above, which shall be valid for 30 days beyond the validity period of the bid.
 9. If the last date of purchasing and /or submission falls on a government holiday, then the next working day shall be considered as the last date. In such case the validity period of the bid security shall remain the same as specified for the original last date of bid submission.

Matters not covered by this notice shall be in accordance with Public Procurement Act, 2063 with amendment and Public Procurement Regulations, 2064 with amendment and other prevailing regulations. Rawabeshi Municipality, Office of the Rural Municipal Executive reserves the right to accept or reject wholly or partially or all the bids without assigning any
