## **Invitation for e-Bids**

- 4. Pre-bid meeting shall be held at RawaBesi Rural Municipality, Office of Rural Municipal Executive, HaramtarKubhinde, Khotang, Nepal at 2078/07/02(19th Oct, 2021) at 12:00 Hours.
- 5. The bid must be submitted through PPMO's website: http://www.bolpatra.gov.np/egp; on or before 12:00 Hrs of 2078/07/08(25th Oct, 2021). Bids received after this deadline will be rejected.
- The bid will be opened in the presence of Bidder's representatives who choose to attend at the time mentioned in table below on 2078/07/08(25th Oct, 2021) at the RawaBesi Rural Municipality, Office of Rural Municipal Executive, HaramtarKubhinde, Khotang.
- 7. Bids must be valid for a period as mentioned in table below after the bid opening and must be accompanied by a bid security issued by Commercial Bank or Financial Institution eligible to issue Bank Guarantee as per prevailing Law or scanned copy of the bid security in pdf format in case of e- bid, amounting to a minimum as mentioned table below, which shall be valid for 30 days beyond the validity period of the bid.
- 8. If the last date of purchasing and /or submission falls on a government holiday, then the next working day shall be considered as the last date. In such case the validity period of the bid security shall remain the same as specified for the original last date of bid submission.
- 9. The person, firm or company black listed as per Public Procurement Act-2063 with amendment, shall be ineligible to submit the bid and also the proprietor of such firm or company shall be ineligible to submit the bid from another new firm or company.
- 10. Matters not covered by this notice shall be in accordance with Public Procurement Act-2063 with amendment and Public Procurement Regulations- 2064 with amendment and other prevailing regulations. RawaBesi Rural Municipality, Office of Rural Municipal Executive, Haramtar Kubhinde, Khotang, reserves the right to accept or reject wholly or partially or all the bids without assigning any reasons whatsoever.
